



## 2024 CALF SCRAMBLE

Junior High Night 6<sup>th</sup>-8<sup>th</sup> Grade

### RULES OF PARTICIPATION

**\*DETACH AND KEEP FOR YOUR RECORD\***

#### 1. PAYOUT VALUES:

CTRR-CS payout values will range from Fifty (\$50) to Five Hundred dollars (\$500).

#### 2. ENTRY FEES:

There is no Entry Fee for the Calf Scramblers. There is a fee for parking and to enter the Chisholm Trail Round-up Rodeo.

#### 3. SCHEDULE:

The participation schedule is as follows:

Orientation	Thursday, June 13, 2024 at 7:30 p.m.
Rodeo Starts	8:00 p.m.

#### 4. ELIGIBILITY:

- a. Participants must have reached their incoming 6th grade year in junior high school, but not exceeded their 8th grade year prior to the start of the CTRR-CS.
- b. Participants must be active members in an FFA or 4-H program and reside in the state of Texas.
- c. Each participant must fully complete the CTRR-CS Participation Forms with the original signatures of the parent/guardian and the participant.
- d. No copies will be accepted.

#### 5. SELECTION OF PARTICIPANTS:

- a. CTRR-CS is limited to 30 participants – 15 girls and 15 boys.
- b. Participants will be accepted to CTRR-CS on a first-come, first served basis.
- c. After the 30 positions have been filled, entries will remain open for alternates.
- d. Alternates will be moved up if an accepted participant does not meet the requirements or is unable to compete.
- e. Alternates will be notified ASAP after a spot becomes available.
- f. Participants and alternates will be notified by the CTRR-CS committee when all spots are filled.
- g. If an approved participant does not show up to the arena on time, he/she will be disqualified.

#### 6. ARENA RULES:

- a. Participants must arrive at 7:30 p.m. on the date of their Scramble for orientation.
- b. Participants who do not arrive on time will be replaced with an alternate.
- c. Participants will carry a lead rope into the CTRR arena. The lead rope will be supplied by the CTRR-CS committee. The lead rope **MAY NOT BE USED AS A LARIAT.**
- d. All calves will be haltered before they enter the arena. The participant must gain control of the calf and snap the lead rope to the ring underneath the halter. Any participant attempting to catch the calf by the halter will be disqualified.
- e. Only one participant will be awarded per calf and, therefore, only one participant should take the calf across the finish line.
- f. Sportsmanlike assistance is permitted.
- g. Participants may not tie the rope to themselves.
- h. If a participant has hold of a calf, no other participant will be allowed to touch the calf unless it breaks away. If two or more participants catch the same calf, the participant farthest away from the head of the calf will be asked to release.
- i. If a participant catches a calf by the tail, he/she will have a limited amount of time to work towards the head of the calf before an arena judge will ask them to release the calf.
- j. Poor sportsmanship, as determined by the arena judge, will result in the participant being disqualified. Undue roughness or abuse of participants or animals will not be tolerated.
- k. Participants will be awarded their final position based on the order in which they crossed the finish line with the calf. In the event participants cross the line at the same time, a coin toss will be used to determine their final position.

- l. The judges who hold the placement cards have the final decision for the finishing positions.
- m. The judges will escort the participants to the side of the arena after they cross the finish line.
- n. Baseball caps, hats or necklaces are not allowed to be worn in the arena during the Scramble.
- o. CTRR-CS reserves the right to modify or change any of the arena rules. Notification of any such modification will be made to the participants prior to the CGTRR-CS event.

**7. PRIZE PAYOUTS:**

- a. Winners will receive a cash award from the Lockhart Chamber of Commerce.
- b. The winners are encouraged to use this award to purchase animals approved by the AST or CEA.
- c. These animals can be used as the participant's FFA or 4-H project.

**8. PURCHASE OF ANIMALS OR FEED:**

- a. Participants will **NOT** be allowed to purchase animals from themselves, immediate family members or their ranches (family ranches or partnerships), or their Agriculture Science Teacher or County Extension Agent.

- 9. FAILURE TO COMPLY:** Participants who fail to fulfill their obligations as stated in these rules will be subject to revocation of the payout monies and will be required to repay the monies to the CTRR-CS.

Entry is limited to the first 15 boys and 15 girls who complete these forms and submit them to the CTRR-CS.

## **CHISHOLM TRAIL ROUND-UP RODEO CALF SCRAMBLE CHILD AND PARENT/LEGAL GUARDIAN PARTICIPATION AGREEMENT**

By my signature below, I, as the parent or legal guardian of the CTRR-CS participant ("Child") named below, affirm that I give consent for the Child's participation in the activities as herein described, and in consideration of being permitted to participate in Calf Scramble – Diamond Cross Rodeo, which includes, but is not limited to the Calf Scramble and includes any activities associated therewith ("Activity") at the Chisholm Trail Roundup Rodeo and Music Festival ("Event") taking place in Lockhart, TX on June 14 and 15, 2024 and otherwise permitted to be present with the Activity or Event that are restricted to the general public, hereby represent, warrant and agree as follows:

I acknowledge that my statements in this Agreement are being accepted by Diamond Cross Rodeo, Chisholm Trail Roundup, Lockhart Chamber of Commerce and the City of Lockhart in consideration for allowing the Child named below to participate in the Calf Scramble at the Event and in permitting me and/or the Child to be present in Restricted Areas.

I agree that I and/or Child shall at all times be considered a visitor. At no time shall I and/or Child be considered an employee, agent, representative or contractor of Diamond Cross Rodeo, in any capacity. I further agree I and/or Child agree NOT to participate under the influence of alcohol or drugs. I understand that it is not the purpose of the Activity to teach safety rules, nor is it the function of any individuals associated with the Activity to serve as guardians of Child's safety. I also understand that I am to furnish Child with any safety equipment I deem appropriate, and I am responsible for the equipment's safety and good operating condition regardless of where I obtain it.

I acknowledge, and have been warned, that participating in the Activity and/or being present in Restricted Areas entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to me, Child, or property. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the Activity. The risks include, but are not limited to, being injured by the calf, which could result in musculoskeletal injuries to the head, neck, back, internal injuries, paralysis and death, among other things. Diamond Cross Rodeo and/or their representatives may be unaware of Child's fitness/abilities. They may give incomplete warnings or instructions, and any equipment used may malfunction.

Child's participation in the Activity is purely voluntary, and I elected to allow Child to participate despite the risks. **I expressly agree and promise to accept and assume all the risks existing in the Activity. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the Released Parties (defined below), from any and all claims, demands, or causes of action which are in any way connected including any such claims which allege negligent acts of omission.** Should any of the Released Parties, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for such fees and costs. I certify that I have **adequate insurance** to cover any injury or damage to I and/or Child may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risks of any medical or physical condition I and/or Child may have.

By signing this Agreement, I acknowledge that if anyone is hurt or property damaged during my and/or Child's participation in Activity, I may be found by a court of law to have waived my right to maintain a lawsuit against the Released Parties on the basis of any claim

from which I have released them herein. I have had sufficient opportunity to read this Agreement. I have read and understood it, and I agree to be bound by its terms.

**Being fully aware that participating in the Activity, or otherwise being present in or around Restricted Areas and/or at the Event will result in my and/or Child's exposure to substantial and serious hazards and risks, I voluntarily and irrevocably assume and accept full responsibility for all such hazards and risks and hereby unconditionally and forever discharge, waive, release, indemnify, save and hold harmless, and agree to defend, Diamond Cross Rodeo, Chisholm Trail Roundup, Lockhart Chamber of Commerce and the City of Lockhart, their respective parents, subsidiaries, affiliates, officers, directors, shareholders, members, employees, representatives, escorts, contractors, volunteers and agents, and those in privity with them, together with all Activity and/or Event venue owners and operators, producers, sponsors, advertisers, promoters, production entities, as well as all Activity and/or Event contestants, bull fighters, judges, officials, stock contractors, and all other parties involved in the production, organization, security, conduct, sponsoring and performance of the Activity, the Event and/or other Activity or Event activities (and each of their respective parents, affiliates, directors, officers, employees and agents) (collectively, the "Released Parties"), from and against any and all claims, demands, suits, liabilities, and responsibilities for any and all property damage, personal injury, death, damage or loss of any kind arising out of or any way related to my and/or Child's participation in the Activity, the Event and/or other Activity or Event Activities, my and/or Child's presence at the Activity, the Event or in any Restricted Area, or otherwise, whether or not such claims, demands, suits, liabilities and other liabilities and other responsibilities are occasioned by the acts, omissions, negligence or gross negligence of any Released Parties.**

I expressly acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of the Released Parties. I authorize and provide full consent to Diamond Cross Rodeo, Chisholm Trail Roundup, Lockhart Chamber of Commerce and the City of Lockhart, their respective subsidiaries, affiliates, officers, directors, shareholders, employees, agents, representatives, volunteers, contractors or others, subject to the release, waivers and indemnities contained herein, to seek and/or provide medical attention/treatment, including the release and distribution of medical records, the respective entities may deem necessary and appropriate, in the event I am unable, unfit or not qualified to make such decisions on behalf of Child.

I hereby agree that the foregoing release, waiver and indemnity provisions extend to all acts of negligence or wrongdoing by the Released Parties, including negligent rescue operations or procedures, and in intended to be as broad and inclusive as is permitted by the laws of the County or State in which the Activity or Event is conducted and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. I shall not now or at any time in the future, directly or indirectly, threaten, commence, or prosecute any action, suit or other proceeding against any Released Parties arising out of, or related to, the claims, demands, liabilities and other responsibilities so discharged, waived and released by me.

I acknowledge the Activity and/or Event may be filmed, recorded, transmitted, reproduced, altered, distributed, exploited and broadcast on one or more television networks and other audiovisual works, that my or Child's name, image, voice, likeness, trace dress, picture and other personal characteristics may be filmed, videotaped or otherwise recorded or captured before, during or after such Activity or Event by film crews from many sources including but not limited to news media, newspaper, radio, TV or cable networks, movie, or other third party shows or film crews granted access to the Activity or Event, and may appear to be displayed, performed, reproduced, transmitted and distributed in many formats or media including but not limited to on television, in newspapers, magazines, websites, and/or radio broadcasts used in TV shows, films, promotional, documentary, reality, highlight shows or feature movies. I hereby grant to Diamond Cross Rodeo (and subsidiaries, sub-licensees and affiliates) and agree that Diamond Cross Rodeo (and subsidiaries, sub-licensees and affiliates) shall own, in perpetuity, any and all rights, copyrights and other intellectual property rights in and to all such broadcasts, films, videotapes, recordings, photographs and audio/visual works.

For real and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and for no additional consideration, I hereby grant to Diamond Cross Rodeo, Chisholm Trail Roundup and its duly authorized agents, licensees and assigns, the right to publicly and commercially use, display, publish, distribute, perform, transfer, license, reproduce, copy, alter, make derivatives of, translate, transmit and otherwise commercially exploit in perpetuity my or Child's name, image, signature, likeness, voice, photograph, persona, trade dress and other publicity rights, including pictures, photographs, films, images and sounds of me, captured, recorded or memorialized at or in, or related to, the Activity and/or Event including before or after the Activity or Event, or in any related activities, its affiliates, sponsors, licensees or sub-licensees, that are put on near the Activity or Event, such as pre- or after-parties, receptions, VIP matters, meetings and the like, in any way, medium or material, whether now known or hereafter created (including, but not limited to, print, television, radio, film and video, any other audio and/or visual productions or works, and transmissions over the Internet). I acknowledge that Diamond Cross Rodeo Company, exclusively owns any and all rights to broadcast, transmit, film, tape, capture, overhear, photograph, print, publish, distribute, collect, capture or record, by any means process, medium or device, whether or not currently in existence, all images, sounds, activities, information and data arising from or during, or related to, the Activity or Event and that Diamond Cross Rodeo shall be the sole and exclusive owner of all rights of every kind and nature in and to such works and in and

to any other works, copyrightable or otherwise, created or derived from the images, sounds, information and data arising from or during, or related to the Activity or Event. I agree not to take action, nor cause others to take any action, nor enter into any third-party agreement, which would contravene, diminish, encroach or infringe upon the foregoing rights. I hereby waive all moral rights in connection with my or Child's appearance or captured image, voice and so forth and hereby waive any right of inspection or approval of such appearance or the uses to which such appearance are put. I further waive all right to injunctive or equitable relief.

I understand that Diamond Cross Rodeo and CTRR-CS event credentials may be issued pursuant to this Agreement. Credentials are the exclusive property of Diamond Cross Rodeo and CTRR-CS must be surrendered upon demand in Diamond Cross Rodeo's sole discretion. Any credential lost or stolen must be reported immediately. Failure to timely report a lost or stolen credential may result in suspension of credential rights. I understand that any credential issued hereunder solely permits me and/or Child to enter Restricted Areas solely in accordance with the rules, directions, instructions and procedures for access as may be established by Diamond Cross Rodeo and CTRR-CS. Diamond Cross Rodeo and CTRR-CS may require that I and/or child carry certain identification, be accompanied by certain individuals, depart such restricted areas, take certain actions, or refrain from taking certain actions, and I agree to fully abide by Diamond Cross Rodeo and CTRR-CS's directives and instructions in that regard. I understand and agree that any credential issued to me and/or Child hereunder is personal to me and/or Child, that I and/or Child may not sell, assign, lend, transfer or give it to any other person or entity, that any attempt to sell, assign, transfer, lend or permit any other person or entity to use it shall result in a fine imposed by Diamond Cross Rodeo of not less than Five Hundred Dollars (\$500.00) and suspension or revocation of the credential. In addition, I hereby INDEMNIFY AND AGREE TO DEFEND Diamond Cross Rodeo and CTRR-CS and all related parties for any damages or injuries arising in connection with such unauthorized sale, assignment, transfer, lending, or use.

I expressly agree that the foregoing provisions, including specifically the release, waiver and indemnity provisions, are reasonable, enforceable and intended to be as broad and inclusive as is permitted by applicable law, and that, if any portion thereof is held to be invalid, it is agreed that the balance shall, notwithstanding such invalidity, continue in full legal force and effect.

I expressly agree that the undertakings and covenants of this Agreement are binding on me as well as upon my spouse, children, heirs, next of kin, legal and personal representatives, successors, and assigns.
